Our Client owns the site that is identified in the Plan at Policy H2, reference 95 (Land at Topsham Golf Academy). We consider that the site should be allocated for residential development and therefore this part of the Plan is supported. We attach representations to the previous version of the Plan (Reg 18) setting out the justification for the allocation (see letter dated 15th January 2024). Further, in terms of deliverability/viability it is important to be aware that the site is the subject of a current planning application (Council Ref: 24/0785/FUL) for residential development for 54 units (detailed).
